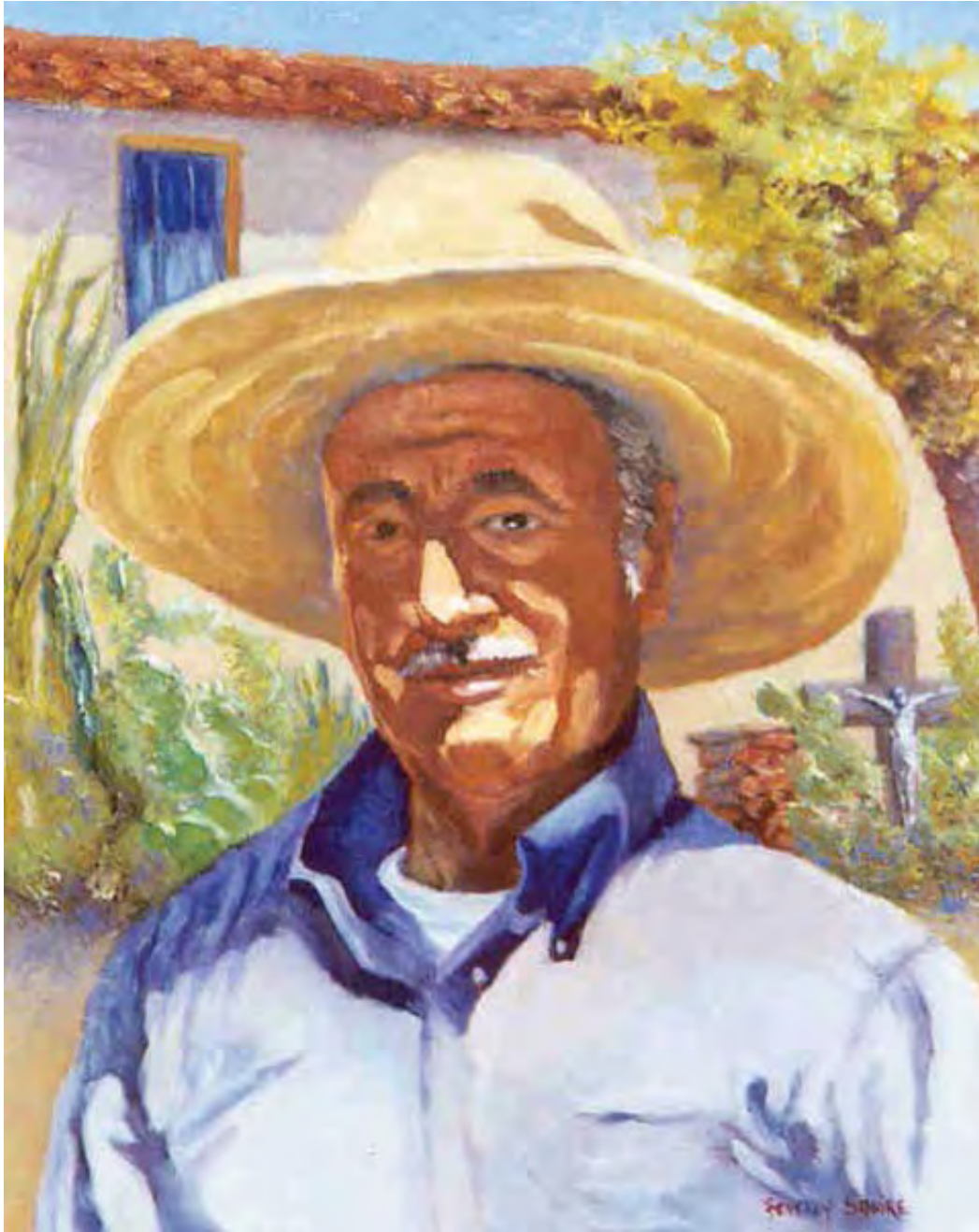

Susan Gutschow and Peggy Moore, Workshop Co-Chairmen, have organized two very exciting workshops with internationally known artists, Jerry Stitt and Gerald Brommer.

Speaking of workshops, there are still a few spaces left in the Jerry Stitt workshop being held Thursday, September 22 through Saturday, September 24 at the Temple City Civic Center Community Room. Jerry is known for his fresh and direct style. He takes advantage of the unique properties of watercolor, encouraging one hue to melt into another. Believing that it is important to simplify one's work to find the most basic way to express an idea, Jerry has been known to compare painting to golf, observing that "the person with the fewest strokes wins." If you've never studied with Jerry, this is a great opportunity!

Fall is the season that makes me feel like a kid in a candy store. There are so many inspiring exhibitions and demonstrations that I hardly know where to start. The group of artists (many of whom are members of MVAL) who traveled with Chris Van Winkle to Ireland in September 2010 will be exhibiting at the Citrus College Library of Art Gallery in Glendora September 17 through October 21, 2011. Watercolor West's 43rd Annual Juried Exhibition opens Saturday, October 15 and runs through December 18, 2011 at the City of Brea Art Gallery. SEPTEMBER DEMONSTRATION

JERRY STITT

You are in for a rare treat. We are honored to have Jerry Stitt as our demonstrator at our September general meeting!



Jerry Stitt was born in Seattle where he worked for the City. He came to painting at the age of 27 when he was inspired by a painter on television who was effortlessly painting bamboo shoots and leaves. He thought to himself he'd like to give it a try. Soon after he enrolled in art school.

Sausalito, California is where he now calls home and has a studio for daily painting and classes. He also teaches around the country for various watercolor societies. He has taught at the University of Washington and the University of Puget Sound and had exhibitions at the Frye Art Museum. His teachers have included Rex Brandt, John Ringen, Sergei Bongart, Robert E. Wood and Christopher Schink. Jerry served in the United States Navy where he was a combat artist. His paintings hang in the Pentagon and in private collections of Sweden's King Gustav, the King of Saudi Arabia, Alaska Airlines, Chase Bank and the Boeing Company.

Jerry Stitt is an elected member of the American Watercolor Society and the National Watercolor Society, and is a life member of the *Puget Sound Group of Northwest Painters* and current member as well as past president of Northwest Watercolor Society. Jerry's work has been featured in *American Artist*, *Watercolor Magazine* (on its cover spring 2006), and in the books *Color & Light for the Watercolor Artist* by Christopher Schink and *Splash – The Best of Watercolor 2008*.

The family of Lisbeth Carol "Bet" Reed, artist, along with Lorraine Christensen, Addy Danforth, Rita DuShane-Jones, Elaine Lawry, Cindy Mellon, Setsuko Okubo, Joan Taylor and Colleen Wadsworth will be celebrating Bet and her work in a memorial exhibition, "Color of a Wonderful Life," from September 15 through October 2 at the La Habra Art Gallery in La Habra.

The show will feature Bet's work as well as work of her friends. The reception is scheduled for Saturday, September 24, 2011 from 2:00 to 4:30 pm at the gallery which is located at 215 N. Orange St, La Habra, CA 90631. The gallery is open Thursday through Sunday, from 1:00 to 5:00 pm.

Bet was born and resided in Los Angeles, CA from 1914 through 2010. According to Chris Van Winkle, artist and art instructor, "Bet Reed was a very unique artist, reacting to her world in her own way. She was always open to new ideas, readily welcomed new environments, and always painted in her own personal style. If ever there was someone who had to paint, that was Bet. She was a joy to be around. Her output was delicious, spontaneous, full of color and excitement. There was no one like her. She has earned her place in the art world"

Tom Fong, also a nationally recognized artist and teacher, says "Bet Reed was a wonderful and unique artist. Her work was very abstract, painted in the language of shapes, color and line. Her work conveyed a composition of inner expression on a personal note. She was a kind and most gracious lady."

JERRY STITT WATERCOLOR WORKSHOP

September 22 -24, 2011

"How to Take the Round World & Make It Look Round on Flat Paper"

Class Description

For watercolorist Jerry Stitt painting is much like golf, "The person with the fewest strokes wins". This statement underscores the artist's belief that it is important to continually simplify a work until the most basic way to express the idea is found. Jerry's style and emphasis are his color choices and the way he makes colors flow together, seamlessly creating mood. "Watercolor should look like it is melting. It is a fluid medium". The artist firmly believes that the key to becoming a better painter comes from getting "a lot of brush mileage."

Each day of the workshop Jerry will begin with a lesson, followed by a demonstration painting. Then everyone paints. Subject matter will be based on participant's own sources. Jerry feels the best source of material is a sketchbook. He stresses doing a thumbnail sketch of the subject. Photographs are another possible source for inspiration but he much prefers sketches and value studies. Since he stresses the melting of colors and shapes into each other, please prepare to include a small desk top easel or block to prop up your backing board and paper. Each day will conclude with a critique.
